TERMS OF THE TRIP AND REFUND POLICY

Departures: Trips will depart from **5 Municipal Way, Langhorne, PA 19047. This is the Middletown Township Police Building, which is two lights north of Maple Ave. (Rt. 213), at Shasta Ave. off North Flowers Mill Rd.** There is a map is on our web site. The bus shall leave promptly at **5:30 AM.** Arrive earlier so that luggage may be packed. Bind your skis and poles together.

Refreshments: Will be provided for the trip to and from destination.

Bus Rules: 1) No smoking of any kind is permitted on the bus. 2) Loud radio playing is prohibited on the bus. 3) The seat you sit in initially is yours for the entire day. 4) Please be courteous to others. Note: the bus is equipped with a restroom.

Payments: Deposits as specified will reserve a spot. **Balance must be received at least 14 days prior to departure date. You must be a member of the club to go on any bus trip.**

REFUND POLICY: Cancellations received **more than 40 days** prior to the trip will guarantee full refund within 30 days. Cancellations received **less than 40 days** prior to departure will not guarantee full refund. Refunds shall be based on the actual expenses incurred by the Club due to the cancellation. Refunds will be paid by the end of the fiscal year.
